Explanation and consequence on patient results:

The HIVp24 values of the QConnect HIVp24 positive control lot DM17085 showed reduced or negative values when tested with the Siemens ADVIA Centaur HIV Ag/Ab Combo Assay. These results were confirmed by internal control tests.

Negative results were only obtained with the Siemens ADVIA Centaur. All other tests which may be used for QConnect HIVp24 (Abbott Architect HIV Ag/Ab Combo, Abbott PRISM HIV Ag/Ab Combo, DiaSorin Liaison XL MUREX HIV Ag/Ab und Roche Elecsys HIV Combi PT ECLIA) are not affected by the problem and show expected positive results. For these tests the control can be used without restrictions.

Patient results are not affected. QConnect HIVp24 is an external quality control to scrutinise the assays through an additional control beside the internal quality control

Actions to be taken by the user:

- Please check if you are using the QConnect HIVp24 control Lot DM17085 (included in the kits DM17148 and DM17150) or have it on stock.
- The mentioned lot DM17085 is not more suitable for use with Siemens ADVIA Centaur.
- Lot DM17085 may be used with Abbott Architect, Abbott PRISM, DiaSorin Liaison XL MUREX and Roche Elecsys according to the instructions of use without any restrictions.
- To request replacement material or get a credit note please contact the DiaMex GmbH or your local distributor.
