Urgent Field Safety Notice (FSN)

Latham bowl leak

August 13, 2024

Dear Distributor,

Haemonetics Corporation is conducting a voluntary field action on certain lots of Latham bowls.

Reason for the Field Notice:

Haemonetics has received reports from the field of instances in which there has been a significant leak of blood from the Latham bowl into the MCS+ equipment during the apheresis procedure. The leak results when the bottom of the bowl becomes detached, which then leads to a termination of the procedure and required cleaning and servicing of the equipment before the next use. The objective of this FSN is to inform our customers of this possible occurrence and the options available.

- Frequency of failures and complaints The estimated rate of occurrence is approximately 330 per million.
- Adverse events There have been no reports of adverse events associated with this leak.

Should you wish to return any affected lots, please contact your Haemonetics account representative. Please note that due to lead times for production, sterilization, and shipping, it may take up to 3 months to receive a full replacement.

Risk to Health:

If the bowl leak happens, as in the reported complaints, there is no harm to the donor because the equipment can detect the leak immediately and stop the procedure. The maximum blood loss due to the bowl being filled with no return during the procedure is 225 ml based on bowl volume. This is less than a whole blood collection, which averages between 450 ml and 500 ml.

The potential for harm to blood center staff due to exposure to blood borne pathogens is unlikely due to the location of the leak (inside the centrifuge of the equipment), the personal protective equipment the blood center staff utilizes as part of standard blood collection process and environment, and blood donor eligibility criteria.
